8. Old Business.

8A. 2025/2026 Committee Report

BCOA: 2025 we will be in Region 1 (Northeast) but no location has been determined.

No BCOA National specialty site has yet been proposed for 2026. BCOA is going to be reviewing proposals over the next few months.

Discuss options for Fall 2026 specialty. We need someone to make a proposal for spring and fall locations.

Motion to hold our spring specialty in Kalamazoo, MI in 2026 – Amy Sikula Second – Frank Zajac Motion passed.

The board discussed having another independent specialty in Crown Point. Pam will look into weekends for the fall to see if there is still a conflict in September, or if we would need to move into October.

8B. Health Clinics in 2024.

- Could we have a health clinic in Illinois? As long as a state licensed vet is in charge, Anne could do thyroid blood draws. Someone would need to find a location and find local vets for echocardiograms or eye exams. Tina will look into this.
- Do we want to sponsor another clinic in July 2024 with Lima Kennel Club?

Motion to continue to partner with LKC on the July clinic in 2024 – Frank Zajac Second – Amy Sikula Motion passed.

8C. Fundraiser discussion.

We didn't do a second fundraiser in the fall with black logo and different colors.
 Are we doing one this winter/spring? Amy Balthrop & Rebecca Heighton-Drollinger

Jamie is looking into Big Frog, as stated under the Ways & Means committee report. It works the same way as the other site we used, except that Big Frog collects the money and then sends a check to the club with our profits. She will gather more information and provide it to the board.

8D. Annual Club Picnic, 2024

We have held picnics in OH, IN and MI. Where do we want to do the 2024 picnic? The board decided not to have another picnic separate from the Lima independent specialty in 2024.

8E. MBC Member Education Series.

Long standing members and Breeder making presentations at MBC events on subjects like their breeding program, starting a breeding program, improving the breed, kennel design, feeding, etc. could be stand-alone event or part of a Specialty or picnic.

Tina will call Nancy Reimer to see if she would be interested in doing a presentation, or write something for the website.

Amy Balthrop/Jamie Bobrowski are looking into putting together an education panel for members, with experienced breeders and the opportunity to put their hands on multiple dogs.

Dr. Erin Runcan from OSU Theriogenology will present for us at our 2024 fall specialty on care of the bitch during pregnancy and whelping. Amy will coordinate with Dr. Runcan. We will need to tell her when the presentation will be given and how much time she will have. The presentation will need to be between the specialties, so 1:00PM is a good time, and she will have one hour.

Final discussion: We will have 2 presentations at the Lima independent specialty: 1) Dr. Runcan, Theriogenology @ OSU will present on care of the bitch during pregnancy and whelping. 2) Liz Duncan-Burge will put together and handout on how to select a good home. She will present if her schedule allows.

8F. Write/update procedures explaining how to put on MBC events.

Rebecca will start updating the show committee guidelines starting in January 2024.

8G. Tabulator discussion. Judy Collopy has been MBC's tabulator for many years. KC no longer has a current address for her. KC wanted to let us know in advance, before we have to send out judges' ballots. We need to find a person who is not involved with borzoi to be the tabulator. We pay the tabulator \$50.00 to sort through the votes and provide the results to the recording secretary.

Amy will asked some of her non-borzoi friends if they would be willing to do this.

Kai Tarot has relevant job experience, is retired, and has reviewed the description of the job. She has agreed to do this if the board would like her to handle it.

8J. Do we want to continue to mail minutes to the membership? Fewer and fewer people are receiving paper copies, and the cost of printing and mailing the minutes is increasing. We should talk to any of our acquaintances about this and discuss again at the next board meeting. Then we can decide if we want to add this to the agenda for the next membership meeting in May, 2024. The board agreed we do not want to make this decision at a board meeting.

Amy S. will send a letter to any members who are still receiving paper minutes when we send these meeting minutes out, explaining the challenges and asking that members pay a fee for paper meeting minutes. We currently have 23 members receiving minutes via US mail. Of those, only 4 do not have an email address on file with MBC. This letter will be presented to the board for review prior to mailing.

9. New Business.

9A. Michigan Hound Club (Jon Steele) would like us to support the entry for Carol Spritzer on Saturday, July 8th.

I have been working with the Michigan Hound Club and have hired Carol Spritzer and Randy Tincher for our panel next July. Ann Arbor KC is using Carol on Saturday for Borzoi.

It would be great if MBC would support the entry for Carol on Saturday the 8th. This year we had 278 hounds at just the Hound Show, one of largest LB hound entries in the country. Jenni and I will take care of all the trophies. Is there a form I need to fill out for the request?

When is the next MBC board meeting to see if we can get approval from the club? Carol doesn't judge often and I think supporting a life member of MBC would be a great gesture. I think so far Afghans, Saluki, Dachshunds, Basset, and several other hound breeds are supporting either Friday or Saturday. The show is turning into a premier hound event in the Midwest.

Motion to Approve Jon's supported entry with MHC – Amy Sikula Second – Frank Zajac Motion passed.

9B. Jill Zamowski will be joining Paper City KC when she moves to WI. She would like to get approval from the board to propose a supported entry with them in September 2024, once she officially joins their club and can propose one. She would like our approval to make that proposal at their meeting in January.

Motion to Approve Jill's supported entry – Amy Sikula Second – Frank Zajac Motion passed.

9C. There is a Chicagoland Hound Show in Shaumburg, IL (no sweeps but there is Best Puppy) and an All-Breed show on Friday, January 19, and additional all-breed shows on Saturday and Sunday. They also have a 4-6 puppy competition every day. Pam proposes a supported entry on Saturday, January 20, with sweepstakes. This site has an attached hotel.

- 9D. Amy B. was going to talk to the Monroe clubs to see about doing a Saturday supported entry. Update? No update this meeting.
- 9E. Should MBC apply to be a 501c3 organization? This would make fundraising much easier, and would allow us to use PayPal for electronic payments. Frank will do some research and bring information to our next meeting.
- 9F. Review of documents for January mailer, including 2027 judges nominations. No comments from the board. Rebecca pointed out that some of the nominees were judging upcoming specialties, and Amy needs to remove those names since they are not eligible.
- 9G. Discussion of the board meeting schedule for 2024. Do we want to change days of the week or times?

Amy proposes that we set up calls for 2024 following this schedule; the third Monday of January, April and July, and the second Tuesday of October at 7:30PM EST.
