AKC NEWS

Proposed amendments to the *Charter & By-Laws of the American Kennel Club* were voted and the following were approved by the Delegate body. (1) Add an object supporting canine health research areas. (2) Expand the eligibility for AKC membership to permit licensed agility clubs that meet the criteria to become AKC member clubs. (3) Reduce the number of yearly Delegate meetings from four to three, and that two meetings be expanded from two days to three days in order to enable increased attendance at the various Delegate Committee meetings.

The Board of the AKC voted to allow Agility trials to be held within 100 miles of each other if the club desiring to hold a new trial obtains the written permission of the club holding an established trial on the same dates, effective September 1, 2013.

AKC Rally® National Championship. The AKC Board voted to create a n AKC Rally® National Championship. The first AKC Rally® National Championship will be held in the spring of 2014 in conjunction with the National Obedience Championship and the National Agility Championship.

Companion Event Application Fees. The AKC Board voted to establish a minimum event application fee of \$25 for Rally, stand alone obedience and agility. For Rally trials with over 30 entries, (based on the previous year's corresponding trial), the application fee will be lowered from \$100 to \$50. This makes Rally consistent with obedience. Also the application fee for a Tracking test will be \$25, effective 1 Jan 2014.

Sanctioned Four - to - Six Month (Beginner Puppy) Competition. The AKC Board voted to amend the Sanctioned Four to - Six Month (Beginner Puppy) Competition Regulations to allow dogs owned or co-owned by professional handlers to be exhibited, if handled by a non-professional handler in these events .

The AKC Board voted to allow any AKC club to become licensed to hold Rally, and to permit all clubs licensed for Rally to hold up to twelve trials in a calendar year. This is effective June 1, 2013.

AKC Community Canine (The Next Step in the Family Dog Program). The AKC Board voted to approve the creation of an advanced CGC testing program called AKC Community Canine. This new test builds upon the skills learned in the CGC test. Together with AKC S.T.A.R. Puppy and CGC, the Community Canine test is the next step in a program focused on canine good manners resulting in enjoyable family companions and friendly community members. Dogs that pass the Community Canine test will be awarded the title of Community Canine (CMC). The AKC Community Canine test will become a new AKC testing program on October 1, 2013.

Premiums. The AKC Board considered a recommendation from the Delegate Dog Show Rules Committee to amend Chapter 4, Section 2 of Rules Applying to Dog Shows to allow for the sending of premium list electronically to reduce expenses on postage and printing. However the Board interprets the current rule to already allow for the sending of premium lists electronically. The rule only requires that the premium list be sent and it is not specified they must be mailed.
