As the anniversary of the death of MBC Member Joyce Lee Brandin of Nightsong Borzoi approaches, her husband and MBC Member Henry Brandin wishes to honor her memory and writes:

Dear Borzoi Owner,

Nightsong Borzoi – Joyce Lee Brandin passed away on April 30, 2009. A true lover of the borzoi breed, Joyce knew other breeder's pedigrees as well as her own. Nightsong did it's share of showing and winning, etcetera. As most people remember, Joyce Lee had numerous talents; showing dogs, dog grooming, collecting borzoi paraphernalia, dog painting on canvas, repairing antiques, weekly training classes with the dogs, and every year planting a new garden at our 7 acre home. She even almost wrote a book on borzoi! She utilized her vast knowledge of the breed when producing good show quality puppies and always strived for improving her dogs, her showing techniques and her knowledge. It has been almost 4 years since her departure and I miss her dearly. Please say a little prayer for Joyce Lee Brandin of Nightsong Borzoi on April 30th.

Memories of Joyce Brandin from Pat Murphy, MBC Member and AKC Judge:

My friendship with Joyce began many years ago when I got my first Borzoi. A good friend had wanted to groom, so she was apprenticing in Arlington Height with Carol Stell and Betty Halesky whose kennel name was Debonaire. They were close friends of Joyce. Anyway, it all came together when I took my first dog to a show and my friend took her new Debonaire dog also. Later on Joyce and the two ladies had a falling-out and she and I became even closer. If I was going to a show and passing by her exit from 94/294 (she lived about a half block off the tollway). I would pick her up and we would go on our merry way. And a merry way it was. She had a real sense of humor and a lot of knowledge of the breed. We had many laughs and many good times together, but Joyce was always late. If she said something was a ten minute trip, I soon learned that it was a 30 minute trip. If you wanted her to be ready by 8, you told her 7. She had no sense of time. Going to the Detroit specialties with Joyce and Henry was a memorable occasion. Henry was the first auctioneer at the MBC dinners, but interest in the auctions waned and they were discontinued. Joyce was very artistic and a very talented lady. Her byline was "Nightsong on Borzoi, like Sterling on silver." I wish I had thought of it!!! Those who knew her knew how much she loved to talk. There was no such thing as a 10 minute phone call with Joyce, but by the time you hung up you knew all the latest Borzoi gossip and then some. She was a "collector" in every sense of the word. On weekends, if she wasn't at dog shows, she was at antique shows, garage sales---any kind of sale she could find, and she found many treasures there. Not just Borzoi things and she would sell or barter them. Her house was like a museum---filled with Borzoi things that one would never see anywhere but in her home. She was very proud of her beautiful and eclectic collection and she and Henry used to have "get-togethers" there after the Grayslake summer shows. She would go without to get a special Borzoi item she wanted. One thing she would never go without was cigarettes. She was a chain smoker, and as you know, she died of lung cancer. I do miss my friend and think of her often. I keep in touch with one of her daughters, Laurel Hocin, and her husband Henry.

Memories of Joyce Brandin from Thomas Kilcullen, AKC Judge: I have known Joyce since handling her first borzoi Thor (CH Sunbarr Thor of Nightsong). Joyce was Joyce. Independent, opinionated, and she had a sense of humor. Her collection of figurines was extensive and a source of pride for her. I'm not going in to much of her life involving dog shows and breeding. I'm sure there are others that can do that. Instead I'll write about a few memories outside of dog shows. She was a night person. She also was a talented dog groomer, when she finally got out of bed. I occasionally helped in her grooming shop. Henry would have picked up most of the dogs. It was mostly a pick up and delivery operation. He would have most of them prepped, bathed and dry before she finally arrived. Getting moving in the morning was not her forte. She was an excellent groomer (one of the best) once she got to it! Being on time was a problem for her, she was notoriously late. I remember the time we had tickets for Hello Dolly with Carol Channing. A friend and I were to meet Henry and Joyce at a particular spot. We waited and waited until we decided to leave so we could make it on time for the show. We did, but they arrived late. No surprise!

Effective April 1, 2013, clubs holding a Rally Trial no longer must hold an Obedience Trial in conjunction with the event. A club holding a Rally Trial must hold an Obedience Trial in the same year, but the events need not be limited in the same manner either in terms of entries or breeds permitted.

The event service fee for all Performance Events will be \$3.50 per entry effective April 1, 2013. This will make Performance Events consistent with Conformation and Companion events.

Effective December 12, 2012, the judge of the Four-to-Six Month Competition may compete in the other classes at the show.

The American Hairless Terrier, the Norrbottenspets, the Grand Basset Griffon Vendéen, and the Portuguese Podengo will become eligible to compete in the Miscellaneous Class, effective January 1, 2014.

An asterisk is to be used to designate **provisional judges** (those with provisional status for the breeds when the panel was approved) in premium lists and judging programs, effective July 1, 2013. An asterisk will also be used to designate Delegate Judges in the Judges Directory.

AKC News (continued)

The policy on Visiting Judges was amended to approve **Visiting Judges** for a group even though they are not eligible to judge all the breeds in that group, as long as they are eligible to judge the breeds constituting at least 80% of the annual entries in that group at the time they are first approved. This will include judges eligible to award CACs in their own country. Previously visiting judges in FCI member countries had to be eligible to award CACIBs in their own countries.

The requirement that a **Permit judge** be observed was eased. If after six Permit assignments, a Permit judge has not been observed by an AKC Executive Field Representative, that judge will be advanced to regular status.

Total AKC entries for calendar year 2012: Performance 252,587; Conformation 1,575,717; Companion 1,368,164. Field trials increased by almost 1,000 entries, while coonhounds declined by 3,300 and earth dogs by 170, respectively. Herding had an increase of over 1,500 entries, followed by more than 3,000 in hunting tests and almost 5,200, or 31%, in lure coursing. In the conformation arena, All-Breed Shows declined 1½%, or 22,300 entries. Group shows were up 4%, 1,650 dogs, and Specialties declined by 36 00. The Open Show and Beginner Puppy contributed by 300 and 2,220 entries respectively. In companion, obedience is at plus 7,300, up almost 5½%, as well as tracking being up 5½%, while rally dropped by 8½%, or 6,400. Our fastest growing sport, Agility, surged by over 11 %, with an increase of more than 117,000 and ended the year with over 1,150,000, the second sport to exceed more than one million in a calendar year. The year ended with an overall growth of 103,538, up more than 3.35%. Our aggregate entries for 2012 were 3,196,468, the most ever in the history of the American Kennel Club.

The Board VOTED to modify Chapter 3, Section 12, Chapter 5, Section 5, and Chapter 13, Section 17 of the Regulations for **Agility Trials** to provide for a change in the equipment used in the Agility Tire Jump. The tire jump will change from a solid tire to a break-away tire. This will be a safety enhancement for the sport. There will be a six -month trial period (March 1 – September 3) during which clubs may use either the solid tire or t he break-away tire. Starting September 4, 2013, clubs will be required to use the break-away tire.

Lure Coursing – Single Stakes The Board VOTED to amend Chapter IV, Section 11, and Chapter VIII, Section 5 of the Regulations for Lure Coursing Tests and Trials, to restrict entries of dogs that have been disqualified by a judge for being aggressive toward an other dog while in competition in a Lure Coursing Stake to only Single Stakes at Lure Coursing trials, unless and until the dog's eligibility has be reinstated. This change is effective April 1, 2013.

Changes Approved for **Obedience**.

- 1. Modify the regulations pertaining to "judging times" to take into consideration the transition between classes.
- 2. Allow any AKC club with the interest and knowledge to become licensed to hold obedience.
- 3. Allow specialty clubs, after first accepting entries from their breed, the option of accepting entries from either breeds in their conformation group or all breeds.
- 4. Make the timing consistent for several types of judge/handler/dog training relationships that prohibit a dog/person from entering under a judge.
- 5. Allow transfers from the "A" to "B" class at the same level provided transfers between classes are allowed by the host club.
- 6. Allow a judge to accept two assignments over the course of a cluster.
- 7. Allow clubs to decide if the obedience trial secretary may enter the trial.
